



## MEMORANDUM OF AGREEMENT



KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement (MOA) duly executed and entered into by and between the following persons and institutions they respectively represent, namely:

COTABATO CITY STATE POLYTECHNIC COLLEGE, an educational institution duly established and operating under the laws of the Republic of the Philippines with postal address at Sinsuat Avenue, Cotabato City, represented in this act by its President, DR. DAMMANG S. BANTALA, who is authorized to do this Act, hereinafter referred to as “CCSPC”.

Sağlık Bilimleri Üniversitesi (University of Health Sciences) (University code:1110), Türkiye’s health themed First and only public university incorporated in Türkiye under the Organization For Institutions Of Higher Education Act (Yükseköğretim Kurumları Teşkilatı Kanunu :6639), and having its address at Selimiye Mah. Tıbbiye Cad.No:38 34668 Üsküdar/İstanbul hereinafter referred to as “SBU”.

Parties agree to the following:

**Whereas**, parties agrees that Health Sciences University at Bangsamoro Sultan Kudarat Vocational School of Health Services (VSHS) will Offer 2 year courses under the name CCSPC with the following courses:

1. Nursing Assistant
2. Physical Therapy Assistant
3. Diploma in Midwifery
4. Pharmacy Technician
5. Care giver (6 months)
6. Radiologic and X-ray Technology

**Whereas**, sharing of management would be 60% from CCSPC and 40% from Istanbul HSU.

**Whereas**, Management Committee will serve as an adviser where Istanbul HSU may refer their decision whenever necessary according to HSU Budget;

**Whereas**, Management committee is constituted by the following officials:

**Whereas**, Istanbul HSU makes a lease for temporary building in Sultan Kudarat or anywhere in Cotabato. After sometimes, Istanbul HSU will to buy and build some educational building for Sultan Kudarat Vocational School of Health Services;

**Whereas**, the offering of programs shall commence on First Semester School Year 2018-2019 specifically, on August 2018;

**Whereas**, Istanbul HSU provides medical equipment and apparatus tools for the programs to be offered;

**Whereas**, in case the provincial government of Sultan Kudarat will lend the old provincial capitol building, Istanbul HSU is willing to pay renovation and rental of the same;

**Whereas**, all registration procedures, public hospital affiliations and such other requirement as may be provided by Philippine law shall be facilitated by the CCSPC; and

**Whereas**, Istanbul HSU may open other branches and open programs when necessary;

**Whereas**, tuition fees would be spent for the operation of the HSVS;


**Whereas**, any amendment or revision of this agreement shall be made through mutual consent of both parties and shall be in writing which shall be attached and shall form as an integral part of the Memorandum of Agreement.


