I- GENERAL INFORMATION, BASIC PRINCIPLES, AND RULES

- 1. The duration of the Medicine and Dental Medicine program is 6 (six) academic years excluding preparatory class. The maximum allowable period for a student to complete the 6(six)-year Medicine or Dental Medicine program is 9 (nine) academic years.
- 2. Within the scope of this program, in order to qualify for a Bachelor's Degree in Medicine or Dental Medicine from both University of Health Sciences (SBÜ) in İstanbul, Türkiye and International University of Sarajevo (IUS) in Sarajevo, Bosnia and Herzegovina simultaneously, students are required to complete the 3 (three) year classes (1st,2nd, 3rd year) at IUS, and, provided that they meet the Turkish language proficiency requirement (B2 level course), complete last 3 (three) year classes (4th,5th,6th year) the fourth, fifth, and sixth classes at the relevant academic units of SBÜ, thereby becoming eligible for a dual diploma.
- 3. Applicants who apply with International Student Admission Exam (TR-YÖS) score shall be exempt from the Written Student Selection and Placement Examination.
- 4. For medicine program; 30 (thirty) international students will be admitted by IUS in the first year. Within the allocated quota, applicants who apply with a valid TR-YÖS result and meet the required success criteria shall be admitted, provided that the number of such students does not exceed 10% of the total international student quota.
- 5. For dental medicine program; 30 (thirty) international students will be admitted by IUS in the first year. Within the allocated quota, applicants who apply with a valid TR-YÖS result and meet the required success criteria shall be admitted, provided that the number of such students does not exceed 10% of the total international student quota.
- 6. However, based on the applications received, the quota may be adjusted, with the approval of both universities, provided that the total number of students does not exceed 50 (fifty) for medicine and dental medicine programs, separately.
- 7. The number of candidates entitled to enroll from the same country cannot exceed 20% of the total quota of relevant program.
- 8. Candidates who are accepted as a result of the additional exam and interview will be eligible for placement in the quotas remaining vacant after the first placement.
- 9. For the 2025-2026 Academic Year, written exam and oral interviews will be conducted to admit students for Medicine or Dental Medicine program at IUS, Sarajevo, Bosnia and Herzegovina and simultaneously at SBÜ, İstanbul, Türkiye. The application deadline for the Student Selection and Placement Exam will be **August 24**, 2025.
- 10. For the 2025-2026 Academic Year, <u>The Student Selection and Placement Exam will be conducted</u> <u>face-to-face on 25 August, 2025, at 11:00 a.m.</u> at IUS, Sarajevo, Bosnia and Herzegovina and

simultaneously at 12:00, SBÜ, İstanbul, Türkiye. The interview exams following the Student Selection and Placement Exam will take place face-to-face at IUS, Sarajevo, Bosnia and Herzegovina and simultaneously at SBÜ, İstanbul, Türkiye between <u>August</u> 26 and <u>August</u> 27, 2025, from 10:00 a.m. to 5:00 p.m.

- 11. The written and interview exam results of candidates who take the Student Selection and Placement Exam are valid for 2 (two) years.
- 12. Candidates taking the exam must have their passports or identity documents with them along with the exam admission document on the exam days.

13. <u>Candidates who apply for the Student Selection and Placement</u> <u>Exam but do not take the written exam will not be admitted to the interview exam.</u>

14. The languages of instruction for the programs at Faculty of Medical Sciences are English and Turkish. During the first, second, and third classes at IUS, courses will be conducted in English. If deemed necessary, up to 30% (thirty percent) of the courses that students will take at IUS may be offered in Turkish. During the fourth, fifth, and sixth classes at SBÜ, the language of instruction will be 100% (one hundred percent) Turkish.

15. International students who do not possess Turkish language proficiency at the B2 level may attend the Turkish Language School program.

- a) They must complete the B1 level of Turkish by the end of the first class.
- b) Students who fail to complete the B1 level will not be allowed to enroll in Turkish-taught courses (if present) during the second and third classes at IUS.
- c) All students must certify that they have attained B2 level proficiency in Turkish in order to continue their education at SBÜ after completing the first three classes at IUS.

16. Students who have completed the first three academic years at IUS but

do not hold a B2 level Turkish Language Proficiency Certificate may continue their education at $SB\ddot{U}$ on the condition that they obtain the required certificate within the maximum allowed period, or they may transfer to other faculty programs at IUS.

17.In the following cases, prospective students shall be exempt from the requirement to present a B2 level Turkish Language Proficiency Certificate:

- a) Native Turkish speakers.
- b) Those who have completed their high school, undergraduate, or graduate education in Turkish.

II- CANDIDATE APPLICATION PROCEDURES

1. The international students who do not require visa for Bosnia and Herzegovina can apply under these

terms.

- 2. Candidates who have obtained a TR-YÖS score of 400 or above are eligible to apply for the UOLP program in the field of Medicine, while those with a score of 350 or above may apply for the UOLP program in the field of Dentistry.
- Application of candidates who are in their final year of secondary education or graduates will be accepted if their status is compatible with the conditions below:
- a) Those who are Turkish citizens by birth and have received permission from the Ministry of Interior to renounce Turkish citizenship, and those who can prove that their underage children, who are registered on the document of renunciation of Turkish citizenship, have a Document on the Use of Rights Granted under the Turkish Citizenship Law. (Article 7 of the Turkish Citizenship Law No. 5901 states that "(1) A child born to a Turkish citizen mother or father in marriage, whether inside or outside Turkey, is a Turkish Citizen." It is useful for candidates who will apply for the quotas from abroad to review the Turkish Citizenship Law),
- b) Those who were foreign nationals and later acquired Turkish citizenship / in this case those with dual citizenship,
- c) Candidates who started their secondary education abroad, those who completed their entire secondary education (high school) in a foreign country other than TRNC (including those who completed their entire secondary education (high school) in Turkish schools opened by the Ministry of National Education in a foreign country other than TRNC).
- 3. The application for the written and interview exams of international students to be admitted to the International Undergraduate Joint Programs in the Field of Medicine and Dental Medicine for the 2025-2026 Academic Year will be accepted at web site, https://apply.ius.edu.ba/ during dates as specified in the guide for the selection and placement exam of international students.
- 4. Candidates who do not upload all the required documents during the application process at https://apply.ius.edu.ba/ will not be considered for pre-evaluation.
- 5. When applicants are found to have applied improperly, their registration will be canceled, even if these applicants meet the application requirements.
- 6. The responsibility for any consequences arising from inaccuracies in the information provided in the online application form lies solely with the candidates. In the identity-related information fields of the online application form, the candidate's passport identity details should be entered without alteration or abbreviation in the Latin alphabet.
- 7. The requested email and telephone contact information on the online application form must belong to the candidates themselves, and each candidate should use only one email address. This email address should

not be used for correspondence or transactions on behalf of other candidates.

- 8. Applicants who apply with a TR-YÖS score are required to submit their official TR-YÖS Result Document.
- 9. Candidates who will apply with TR-YÖS and a Blue Card must also submit their Blue Card during the application process.
- 10.If the original high school diploma and transcripts of grades are not issued in Bosnian or English, submitting the translation of the mentioned documents into these languages by Sworn Translation Offices is mandatory.
- 11. Candidates who do not have a high school diploma and apply with the International Baccalaureate (IB) Result Certificate obtained at the end of high school graduation exams do not need translation.
- 12.A photograph of the candidate must be added to the relevant field on the online application form. This photograph should be taken from the front to ensure easy recognition of the candidate and should have been taken within the last six months. There should be no significant changes in the candidate's appearance that could affect their recognition in the photograph on the day of the exam. If the Exam and Interview Commission Chairperson finds it difficult to identify the candidate from the photograph, the candidate will not be admitted to the written and interview exams.

III- PAYMENT OF TUITION FEE

- 1. The tuition fees paid by candidates who have earned the right to enroll in the relevant program based on the Student Selection and Placement Exam results and complete their registration but do not continue their education will not be refunded.
- 2. The students are required to pay, in addition to the designated tuition fee for their studies in Bosnia and Herzegovina, the fees for the Turkish Language School, may they be enrolled. During the years in which students are actively enrolled at IUS, all fees expected to be paid by the students shall be announced and collected by IUS.
- 3. The students are required to pay the tuition fees, as determined, for the respective academic years during their studies in Türkiye. While actively enrolled at SBÜ, all applicable fees will be announced and collected by SBÜ.
- 4. Students are fully responsible for covering their living expenses while studying outside their home country, including:
- (a) Transportation,
- (b) Food and accommodation,
- (c) Health insurance (all students enrolling must obtain health insurance before starting their studies) and medical service fees,

- (d) Textbooks,
- (e) Clothing,
- (f) Miscellaneous personal expenses,
- (g) Passport, visa, residence permit, and related fees.
- 5. IUS and SBÜ are not obligated to provide financial support (excluding scholarships) to students under any circumstances.
- 6. The annual tuition fee must be paid in accordance with the procedures and regulations of each institution. Tuition fees are paid in two equal installments. The first installment is due at the beginning of the academic year or during the re-enrollment period. The second installment is due at the beginning of the second semester.
- 7. Students' financial obligations to each institution are independent of each other. Neither institution is liable to the other for any unpaid fees by students.
- 8. Annual tuition fee for the Medicine Program: 12500 EUR for International Students.
- Annual tuition fee for the Dental Medicine Program: 10000 EUR for International Students.
 Students enrolled in the Turkish language school will be charged 250 EUR per module (4 modules 1000 EUR in total).

IV- STUDENT SELECTION AND PLACEMENT EXAM

- 1. Exam applications of the candidates are examined by the Student Selection and Placement Examination Commission. After the examination of the documents, the Commission determines whether the information and documents are complete. Candidates whose "written exam applications" are accepted at the end of the examination, are required to have their passport and/or ID cards with them on the exam day.
- 2. Student Selection and Placement Exam will be held on 25 August 2025 at 11:00 a.m. IUS, Sarajevo, Bosnia and Herzegovina and simultaneously at SBÜ, İstanbul, Türkiye on 25 August 2025 at 12:00.
- 3. Student Selection and Placement Exam consists of <u>50 questions in total and will last for 75 minutes</u>. The examination will consist of <u>10 questions in Mathematics</u>, <u>10 in Physics</u>, <u>15 in Biology</u>, and <u>15 in Chemistry</u>, making a total of 50 questions.
- 4. There are **five** (5) **multiple-choice** answers in the exam questions, and only one of them is the right answer. Candidates must mark the correct option for each question on the optical form (answer paper) that will be given to them during the exam.

- 5. The evaluation of candidates' applications and the implementation of the threshold score fall under the authority of the interview (oral exam) committee, which also reserves the right to decide whether or not to fill the available quotas. Meeting the application requirements does not guarantee admission.
- 6. In order to minimize the mistakes that can be made in the optical form (answer paper), the examiners will inform the candidates about how to mark the answers on the optical form before the exam starts.

V- STUDENT SELECTION AND PLACEMENT INTERVIEW EXAM

- 1. Student Selection and Placement Interview Exam is an exam to be administered by the Interview Commission after the written exam. The list of candidates who will be called for the interview will be announced on the website of our university at www.ius.edu.ba. Candidates are required to have their passport and/or ID with them when coming to the interview.
- 2. Interview Exam will be held at IUS, Sarajevo, Bosnia and Herzegovina and simultaneously at SBÜ, İstanbul, Türkiye, between 26 August and 27 August 2025 at 10:00 a.m.- 5:00 p.m. in determined time spots for each candidate, separately.

VI- EVALUATION OF SCORES FOR STUDENT SELECTION AND PLACEMENT

- 1. In line with the criteria accepted by our university, the score on the high school diploma or for those students who do not have a high school diploma, the score on the Baccalaureate (IB) Result Certificate (scientific numerical, literature verbal) obtained at the end of the high school graduation exams, and the scores obtained both at the Selection and Placement Exam and the Interview Exam will be considered to evaluate the success of candidates. The success score of the candidate is calculated by taking 50% of the result of the Student Selection and Placement Exam; 20% of the high school diploma grade or the score of the Baccalaureate (IB) Result Certificate (scientific numerical, literature verbal) obtained at the end of the high school graduation exams, 30 % of the interview exam result. Students will be accepted in the relevant program based on the total score obtained. In case of equality, the younger applicant (based on date of birth) shall be given priority.
- 2. For applicants who apply with a TR-YÖS exam result document, the final success score is calculated as follows: 50% of the applicant's TR-YÖS score (converted to a 100-point scale), 20% of the high school diploma grade or IB Result Certificate score, and 30% of the interview score. Applicants are admitted to the relevant program based on their total score. In case of equality, the younger applicant (based on date of birth) shall be given priority.
- 3. The interview exam results of the candidates will be announced on the official website of the IUS.
- 4. Candidates who succeed in the additional exam and interview will be assigned to the vacancies left

unfilled during the initial placement process.

5. Final registration will be made to the IUS according to the success score ranking in the announced list.

VII- DOCUMENTS REQUESTED FROM CANDIDATES FOR REGISTRATION

- 1. The online application form along with the documents below:
- Copy of passport (valid for at least two years)
- High school diploma and transcript of grades
- TR-YÖS Result Document (Required only for candidates applying with TR-YÖS)
- Blue Card (Required only for candidates applying with both TR-YÖS and a Blue Card)
- Certificate of English language proficiency TOEFL (minimum 72)

Applicants from non-visa regime countries are allowed to sit for the Student Selection and Placement Exam and interview without submitting a TOEFL certificate. Those who pass the exam, fulfill the criteria, and decide to enroll will be required to submit TOEFL certificate later the exam or take the IUS ELS Proficiency Exam upon arrival. If a prospective student lacks the necessary level of English proficiency to successfully pass the selection and placement examination, including the interview process, the responsibility for this outcome shall rest solely with the student.

- Motivation letter
- If the application is accepted, the candidate will be informed of the next steps.
- 2. Applications of those who present false, forged, incomplete or false documents in the application, placement and registration process are rejected. If the candidates are registered, regardless of the period of education, their registration will be cancelled. Necessary legal proceedings are initiated against those whose actions and transactions constitute a crime.
- 3. Candidates who do not register in the system by the application deadline of **August 24, 2025**, will not be allowed to take the exam.

VIII- REQUIREMENTS REGARDING TURKISH AND ENGLISH PROFICIENCY

- 1. The students <u>can continue</u> their education at SBÜ in İstanbul, Türkiye, if only they are at least **B2 level** according to the result of the Turkish Proficiency Exam conducted by the IUS or the <u>Turkish Language</u> <u>Proficiency Certificate obtained from the Turkish and Foreign Language Application and Research Centers (TÖMER) and Yunus Emre Institutes.</u>
- 2. Students who do not have at least **B2 level Turkish Proficiency Certificate** are directed to the Turkish language class.

- 3. In the following cases, prospective students shall be exempt from the requirement to present a B2 level Turkish Language Proficiency Certificate:
- a) Native Turkish speakers.
- b) Those who have completed their high school, undergraduate, or graduate education in Turkish.
- 4. Based on the results of the English Proficiency and Placement Exams, students who are required to attend the English Language School of the International University of Sarajevo can find information regarding tuition fees and other details on the website: https://els.ius.edu.ba/en.
